Accordingly, the first term of Mrs. Neeta Shah as Independent Director is due to expire on 1<sup>st</sup> February, 2024.

As per Section 149(10) of the Companies Act, 2013 ("the Act"), an Independent Director shall hold office for a term of up to 5 consecutive years on the Board of a Company but shall be eligible for re-appointment for another term of up to five consecutive years on passing a special resolution by the Company. Based on the performance evaluation and recommendation of the Nomination and Remuneration Committee and in terms of the provisions of Sections 149, 152 read with Schedule IV and any other applicable provisions of the Act and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('the SEBI LODR') Mrs. Neeta Shah who being eligible and who has offered herself for re-appointment as an Independent Director, is proposed to be re-appointed as Independent Director for another term of three consecutive years with effect from 2<sup>nd</sup> February, 2024 and will not be liable to retire by rotation.

In terms of Section 149(7) of the Act, Mrs. Neeta Shah has submitted the declaration of independence stating that she meets the criteria of independence as provided in Section 149(6) of the Act and Regulation 16(1)(b) of the SEBI LODR. Copies of the draft Letter of Appointment of the Independent Director is available for inspection by Members at the Registered Office of the Company between 11.00 a.m. and 1.00 p.m. on all working days upto the date of ensuing Annual General Meeting.

Mrs.Neeta Shah is Bachelor of Arts and Bachelor of Education. She has good exposure in Marketing and also been prominently involved in various social welfare activities. The Board is of the opinion that she possesses requisite skills & experience relevant to the Company's business and it would be in the interest of the Company to have her association with the



Company as Independent Director.

In the opinion of the Board, the aforesaid Director fulfils the conditions specified in the Act read with the Rules made thereunder and the SEBI LODR for being appointed as an Independent Director of the Company and is independent of the management.

Brief profile of Mrs. Neeta Shah who is proposed to be appointed as Independent Director, as required under Secretarial Standard on General Meeting ('SS-2') and Regulation 36(3) of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, is given in "Annexure A".

Mrs. Neeta Shah is not disqualified from being appointed as Director in terms of Section 164 of the Act and is eligible for payment of sitting fees and commission, if any, as payable to Non-Executive Directors of the Company.

Your Directors are pleased to present herewith the 52<sup>nd</sup> Annual Report of the Company along with the Audited Financial Statements for the year ended 31<sup>st</sup> March, 2023.

#### 2) COMPANY'S PERFORMANCE AND OPERATIONS:

The Company's performance improved during the under review. The revenue for the year ended 31<sup>st</sup> March, 2023 stood at Rs. 28,384.93 Lakhs as against Rs. 25,877.80 Lakhs in the previous year. The rise in revenue is mostly attributable to the partial commencement of activities at the Porbandar Plant as well as change in product mix. The total income from operation (including other income) grew by 10.58% and stood at Rs 29,331.64 Lakhs as against Rs 26,525.70 Lakhs in FY 2021-2022. Consequently, Net Profit after Tax increased by 79.86% and stood at Rs.1,262.65 Lakhs as against Rs. 702.03 Lakhs in the previous year ended 31<sup>st</sup> March, 2022.

The Company reported decline in export sales which stood at Rs. 6,096.23 Lakhs as against Rs. 6,289.61 Lakhs in the previous year ended 31<sup>st</sup> March, 2022 due to decrease in consumption trend across the globe on account of inflationary pressures.

On consolidated basis, total income from operation (including other income) grew by 13.4% and stood at Rs 31,008.44 Lakhs as against Rs 27,344.97 Lakhs in FY 2021-2022. Consequently, Net Profit after Tax increased by 107.2% and stood at Rs.1,421.36 Lakhs as against Rs. 686.10 Lakhs in the previous year ended 31<sup>st</sup> March, 2022.



Your Company also runs wind power plants of 11.1 Mega Watt (M.W.) in Rajasthan and Karnataka, which are operating satisfactorily. During the year under review, the gross revenue from the sale of power stood at Rs. 690.71 Lakhs as compared to Rs. 708.62 Lakhs in the previous year ended 31<sup>st</sup> March, 2022. The Company is also deliberating on measures required to be taken for further improvement.

Your Company has a power plant capacity of 18 M.W. out of which 9 M.W. is coal based whereas 9 M.W. is based on furnace oil. Due to high fuel costs and high per unit cost of power due to partial operations at the Porbandar plant, the power plant is operated on need basis.

The increase in the turnover and profit, at standalone and consolidated level, is attributable to resumption of Porbandar Plant and better performance of the subsidiary.

With respect to the operations of the Company's Plant at Porbandar, the Hon'ble Industrial Tribunal, Jamnagar, vide its order dated 15<sup>th</sup> September, 2022, approved the application filed by the Company for closing down the unit producing the Bauxite based products since 30-09-2021 for want of availability of the specialized grade Bauxite, which is the main raw material for production of brown fused alumina and calcined bauxite. However, the order does not affect the other running units which produce non-bauxite-based fused products at the same location.

The Company also deals in the business of Chamotte product, which is mainly used as raw material in the refractory industry. The Company had signed a Memorandum of Understanding (MOU) with Ashapura Minechem Limited, Associate Company of the Company for manufacturing of Chamotte on job-work basis. Since the Company has a sizable customer base for Refractory products, the Company receives and processes the customer orders for Chamotte. Therefore, subsequent to the year under review, in order to eliminate the job work process and its associated costs, the Company purchased the Chamotte Plant/Unit located at Baraya, Gujarat, along with its associated Land & Building from Ashapura Minechem Limited enabling the Company to manufacture directly and to drive the entire value chain of Chamotte products through the Company.

During the year under review, there was no change in the nature of business of the Company.

#### 3) CHANGE OF NAME OF THE COMPANY

The Company manufactures and distributes specialty value-added ceramic goods like ceramic proppants for the oil and gas industry as well as ceramic solutions for the abrasives and refractory industries. The Company also caters to several industries beyond the Abrasives Segment. Further, the Company also has plans to consolidate its position in the field of advanced technology-based ceramics.

Hence, in order to align the name of the Company with its business activities, the Company, subsequent to the year under review, changed its name from Orient Abrasives Limited to Orient Ceratech Limited. The word "Ceratech" accurately reflects the business of the Company and conveys the essence of the Company's operations and future vision and aspirations.

The aforementioned business was conducted via postal ballot. On May 17, 2023, the Shareholders approved the name. Subsequently, the ROC approved the name and issued "The Certificate of Incorporation pursuant to change of name" on May 26, 2023.

To reflect the change of name in the regulatory authorities' records, the essential steps have been taken.

#### 4) DIVIDEND:

Considering the Company's improved financial performance and the dividend history, your Directors are pleased to recommend a dividend @ 25 % per share on the face value of Re.1/- each viz. Re.0.25/- per Equity Share for the Financial Year ended 31<sup>st</sup> March, 2023. Payment of dividend is subject to the approval of the shareholders at the ensuing Annual General Meeting. The Dividend will be paid out of the profits for the year.

The Dividend if declared will involve a total outflow of Rs. 299.10 Lakhs which will be subject to deduction of tax at source as applicable and shall be payable during Financial Year 2023-24.

#### 5) TRANSFER TO RESERVES:

The Company has not proposed to transfer any amount to General Reserve.



#### 6) SHARE CAPITAL:

During the Financial Year 2022-2023, there was no change in the authorized, issued, subscribed and paid-up share capital of the Company. As on 31<sup>st</sup> March, 2023, the Company is having authorized share capital of Rs. 18,00,00,000/- (Rupees Eighteen Crores only) consisting of 14,00,00,000 (Fourteen Crores) Equity Shares of Re. 1/- each and 4,00,000 (Four Lakhs) 6% Redeemable Cumulative Preference Shares of Rs. 100/- each.

The issued, subscribed and paid-up equity share capital of the Company remains unchanged. The break-up of issued, subscribed and paid-up equity share capital is provided in Note No 14 of Financial Statements.

During the year under review, the Company has not issued shares with differential rights as to dividend, voting or otherwise or bought back any of its securities. The Company has not issued any sweat equity/bonus shares/employee stock option plan, under any scheme.

#### 7) TRANSFER TO THE INVESTOR EDUCATION AND PROTECTION FUND (IEPF):

Pursuant to the provisions of Section 124(5) of the Companies Act, 2013 ("the Act"), your Company has transferred Rs. 11,34,100.50/- during the year to the Investor Education and Protection Fund (IEPF). This amount was lying as unclaimed/unpaid with the Company for a period of 7 (Seven) years after the declaration of Final Dividend for the Financial Year ended 2014-15.

Further, as required under Section 124 of the Act, 34,393 equity shares, in respect of which dividend has not been paid or claimed by the shareholders for seven consecutive years or more, have been transferred by the Company to IEPF during the Financial Year under review. Details of shares transferred have been uploaded on the website of IEPF as well as the Company at <a href="https://www.orientceratech.com">www.orientceratech.com</a> as on 31<sup>st</sup> March, 2023 a total of 36,55,898 Equity Shares of the Company were lying in the Demat A/c of the IEPF Authority.

The shareholders have an option to claim their shares and / or amount of dividend transferred to IEPF, in the prescribed form available on <a href="https://www.iepf.gov.in">www.iepf.gov.in</a>. No claim shall be entertained against the Company for the amounts and shares so transferred.

The Company has initiated necessary action for transfer of shares in respect of which dividend has not been paid or claimed by the members consecutively since FY 2015-16.

The voting rights on shares transferred to the IEPF Authority shall remain frozen until the rightful owner claims the shares. Any further dividend received on such shares shall be credited to the IEPF Fund.

#### 8) DEPOSITS:

During the year under review, your Company has not accepted any deposits within the meaning of provisions of Chapter V – Acceptance of Deposits by Companies of the Companies Act, 2013 read with the Companies (Acceptance of Deposits) Rules, 2014.

#### 9) SUBSIDIARIES / JOINT VENTURES / ASSOCIATE COMPANY:

As on date, the Company has two subsidiaries (i) Orient Advanced Materials Private Limited (OAMPL) (ii) Orient Advanced Materials FZE (OAMFZE).

During the financial year under review, Orient Advanced Materials Private Limited performed outstandingly and increased its revenue by 325% and stood at Rs. 4,348.24 Lakhs as compared to the previous year and reported a net profit after tax of Rs. 170.82 Lakhs as against the net loss of Rs. (15.93) Lakhs in the previous year.

Subsequent to the year under review, in order to meet the financial requirement of OAMPL, the Company invested further capital of Rs. 5,00,00,000/- (Rupees Five Crores Only) on 26<sup>th</sup> May, 2023. OAMPL issued and allotted 50,000 Equity Shares of Rs. 10 each at a premium of Rs. 990/-each to the Company.

Further, in order to expand its business globally, the Company formed and incorporated one wholly owned subsidiary named Orient Advanced Materials FZE in Hamriyah Free Zones, UAE. The Company invested AED 35000. OAMFZE issued and allotted 35 shares of AED 1000/- each. The said WOS is yet to commence its business.

Further, the Company was also directed to pay compensation under the Industrial Disputes Act, to those employees who are / were employed in that unit, immediately before the date of application.
- (ii) In order to facilitate the Company's intention to explore and diversify its business outside India, the Company established a wholly owned Subsidiary in Hamriyah Free Zone Authority, named Orient Advanced Materials FZE. w.e.f. 5<sup>th</sup> December, 2022, by investing 35000 UAE Dirhams [i.e. by subscribing to 35 Equity Shares of 1000 AED each.]
- (iii) Subsequent to the year under review, vide a Board Resolution passed on 12<sup>th</sup> April, 2023, and approval / consent of Members obtained vide Postal Ballot on 17<sup>th</sup> May, 2023, the Company had resolved to change the name of the Company from 'Orient Abrasives Limited' to 'Orient Ceratech Limited'. The necessary compliances were carried out by the Company and Approvals obtained from the concerned Registrar of Companies. The change of name was effected w.e.f. 26<sup>th</sup> May, 2023.
- (iv) Subsequent to the year under review, the Company on 13<sup>th</sup> June, 2023, paid penalty of Rs. 101480/- to NSE Towards payment of fine for non-compliance with Reg. 18 of SEBI(LODR) Regulations for the quarter ended June 30, 2019.





#### MANAGEMENT DISCUSSION AND ANALYSIS REPORT

#### Overview:

This report is an integral part of the Board's Report and covers management perspective on economic environment, industrial scenario, business performance, opportunities, threats, risks & concern, internal control etc. during the Financial Year 2022-2023. This should be read in conjunction with the Company's Financial Statements, the schedules, and notes thereto and other information included elsewhere in the Annual Report.

#### **Economic Overview:**

As the Global economy was recovering from receding pandemic, war in Ukraine broke out in February 2022 resulting in inflationary pressures across the developed nations. Prices of food, fuel and important commodity items rose sharply. As inflation rates accelerated, central banks of advanced countries responded with monetary policy tightening measures. In the South Asia region, many developing countries faced severe economic stress due to the combination of higher import prices, devaluing currencies, increasing living costs and appreciating dollar, making debt servicing more expensive. Even in this backdrop, the Indian economy is staging a broad-based recovery across sectors, and the Indian economy is positioned to ascend the pre-pandemic growth rates very soon. Private consumption in H1, FY23 is the highest since last 8 years leading to a boost in production activities and enhanced capacity utilisation across sectors.

For India, 2022 was a landmark year as it marked the 75<sup>th</sup> year of India's Independence and India became the 5<sup>th</sup> largest economy in the world. India's GDP growth accelerated to 6.1% in Q4, FY23, making it the fastest among major economies. Exports of goods and services accounted for 23.5% of GDP, the highest since 2014-15, while Gross Value Added (GVA) in construction sector, agriculture sector, and financial services sector grew at more than 5%, which shows increase in economic activities in these sectors. The Indian economy remains stable and will continue to be among the fastest growing major economies of the world in FY24, with estimates from major economic bodies pegging the GDP growth rate to be more than 7-7.5%. This shall materialize in to increased industrial output and infrastructural development, leading to a good potential growth opportunity for your Company in the sectors of interest.

#### **Industry Scenario:**

Indian Steel Industry is slated for a sustained growth due to an amalgamation of factors, ranging from Policy support from the Indian Government, increased investments in the sector, and growing demand in related industries like construction, automobiles, capital goods, and consumer durables. Steel demand in India is expected to reach around 130 MnT by the end of this year and expected to rise by about 6% in next fiscal year to reach 137 MnT. In the long term, domestic steel market is on a strong footing with the Government announcing PLI schemes for value-added steel, leading to an additional investment of Rs. 30,000 crores in the domestic steel sector.

Growth in the refractory Industries is directly linked to the growth in industries such as steel, glass, cement, and non-ferrous metals where the refractories are used in high-temperature applications. With the Indian Government's push towards the growth in infrastructure - roads, ports, and airports, it is also expected to drive demand for refractories. The industry reported a decline in profitability during H1 of FY23, due to higher input costs, however, the revenues increased by over 15%, due to increased demand in related sectors. Government of India is looking to include refractories in the PIL scheme 2.0 for steel, as the steel industry is the biggest consumer of refractories, with about 70% of total usage. With the projected growth in steel, the existing 15,000 crores refractory industry is expected to reach 3 MnT by 2030, even with conservative estimates. Anticipating this demand rise, major refractory companies have announced their expansion plans to increase their capacities. Despite the positive outlook, several challenges including increasing competition from other countries apart from China, fluctuating raw



material prices, and environmental regulations, dampen the growth of refractories. To remain competitive, refractory manufacturers in India are investing in new technologies and processes to improve efficiency, reduce costs, and reduce their carbon footprint.

The global oil and gas industry has earned record profits in 2022, with a sharp increase in their free cash flows to its highest ever \$1.4 trillion. The market grew from \$6.9 trillion to \$7.3 trillion at a rate of 4.9% last year and is expected to grow to \$8.7 trillion by 2027, at a CAGR of 4.3%. There has also been an increased push towards artificial intelligence and big data analytics in this sector to drive further profitability. The overall crude oil production continues to decline y-o-y, further increasing the volatility in crude oil prices through the year. With an increasing shift towards green energy across sectors, same is being witnessed even in the major O&G companies. This has resulted in reduction of new oil well exploration, and oilfield services giants like Schlumberger Limited, focusing on increasing their fracking activities in existing wells. This will lead to increased demand for specialty ceramic products like propants.

Your Company has very recently forayed in to B2C segment with its Building Materials and Construction Chemicals division, through the brand Cetcon. Residential demand received a boost post the pandemic. Sentiments were bolstered due to pent up demand, developer discounts, historically low interest rates and the Government support. Housing sales across major seven cities like Mumbai Metropolitan Region, Delhi-NCR, etc., touched an all-time high in the year 2022 at around 365,000 units. The real estate industry is likely to witness a record completion of projects in the current financial year. Housing projects worth more than Rs.8 trillion are likely to be commissioned in 2023-24 most of which include projects under the Pradhan Mantri Awas Yojna (PMAY). Under the PMAY-Gramin scheme, the Government has targeted to build 29.5 million low-cost homes for the rural poor, of which, more than 20 million houses have been constructed. The Government aims to complete the construction of the remaining houses by March 2024 ahead of the general elections.

#### **Opportunity and Threats:**

Your Company is a challenger in most of its business divisions, competing with major domestic players as well as facing stiff competition from China both in terms of pricing and scale. With India's projection to reach 300 MnT annual capacity of Steel by the end of this decade and parallely 3 MnT of capacity for refractories, this vision requires heavy investment in Research and Development initiatives, as technological advancements are driving down per unit consumption in Steel. Ceramics raw materials division is facing challenges in terms of consistent high quality raw materials and the costs are shooting up as well. Fuel price is another challenge your Company is dealing with and trying to find alternatives. There are industry calls for beneficiation of ores such as Magnesite, for reducing dependence on single source raw materials.

In Speciality Ceramics division, your Company is the only major producer of Ceramic Proppants in the country. With the Company's location advantage for supply to the major markets in the Middle East, your Company has an edge in this space in short term. There is an opportunity for healthy growth in exports market as alternative suppliers and in domestic market as the only major manufacturer in the country. Long term advantages will be driven by continuous investments in R&D to drive down the production cost. New markets are being developed in the Oceania region as well as in some parts of Europe.

Building Materials business is a very competitive landscape, with incumbent industry giants having their established market shares over the years. Your Company's opportunity across businesses lie in being cost competitive, gaining market share from incumbents and outpacing their growth rates, and launching new grades and products at speed to increase your Company's addressable market.

#### **Risks and Concerns:**

Around 25-30% of the refractory products are still imported from China and the competitive pricing offered by China, dampens domestic refractory profitability growth. Dependence on Steel Industry is also a major risk for refractories. Also, capacity utilizations in India remains low at just about 55-60% levels. Raw materials availability and increased prices remain major concern for ceramics division.

Growth in the world demand for Oil is expected to decline with the increased shift towards cleaner energy. In particular, the use of oil for transport fuels is set to decline after 2026 as the expansion of electric vehicles, the growth of biofuels and improving fuel economy reduce consumption. Price volatility remains a major concern in this segment.

Building Materials being a new business line, will require time to stabilize and contribute to the Company's financials. Sector demands high working capital, branding spends and creating a robust supply chain, which will come with its gestation period. Your Company has been more attuned to the B2B business models with its Ceramics division. Building Materials division



being majorly a B2C model, will come with its unique risks and challenges for your Company.

#### **Outlook:**

India's GDP growth forecast has been slated to grow around 6-6.5% by various world bodies such as World Bank, IMF, amongst others. This is attributed to strong domestic investments and reflects sentiments due to stronger than expected growth in Q3 and Q4 of FY23. However, concerns remain due to global financial uncertainty – including higher interest rates, slower recovery in China, debt distress in emerging economies and threats to trade due to geo-economic fragmentation. The Refractory industry is projected to grow in tandem with growth in cement, steel, and related industries, providing an opportunity for your Company's refractory and ceramic raw materials divisions. The Oil & Gas industry is slated to continue growing, with expected peak in global oil demand by 2027. Healthy balance sheets of the Upstream Oil companies will drive further capital investments and opportunities. Shift in the trend towards cleaner energy remains a risk in the long term. Being a comparatively smaller player and a challenger in most of its divisions, your Company is expected to outperform industry growth rates and gain market share from competitors.

#### Internal Controls systems and their adequacy:

Your Company has proper and adequate internal control procedures and vigilance system in place that are commensurate with its size and nature of operations to provide reasonable assurance that all assets are safeguarded, transactions are authorised, recorded and reported properly. These controls have been developed and designed in a manner to properly maintain accounting records for ensuring reliability of financial reporting, monitoring of operations, protecting assets from unauthorized use or losses and compliance with regulations.

On the recommendation of the Audit Committee, the Company appointed M/s Atul HMV & Associates LLP as the Internal Auditors of the Company for the financial year 2022-2023. The internal auditors of the Company conduct audit of various departments and areas. Observations made in internal audit reports on business processes, systems, procedures and internal controls and implementation status of recommended remedial measures by the Internal Auditors, are presented quarterly to the Audit Committee. The statutory auditors also provide assurance on the adequacy of the internal control systems in the Company.

### Segment-wise performance

Please refer Note No. 39 of the Financial Statements.

#### **Segment:**

Segment performance is evaluated and monitored based on profit or loss and is measured consistently with the statement of profit or loss. Operating segment have been identified on the basis of nature of products and other quantitative criteria specified in the Ind AS 108. The chief operational decision maker monitors the operating results of its business segment separately for the purpose of making decision about resource allocation and performance assessment.

The Board of Directors of the Company has authorised its KMPs to assess the financial performance and position of the Company, and make decisions in normal course of business operations. For key strategic decisions, the Board of Directors take decisions after evaluating the possible options and recommendations given by the management.

## **Segment revenue and results:**

Unallocable expenditure which are not directly attributable to any business segment are shown net of allocable income.

#### Segment assets and Liabilities:

Segment assets include all operating assets used by the operating segment and mainly consist of property, plant and equipment, trade receivables, inventories and other operating assets. Segment liabilities primarily includes trade payable and other liabilities. Common assets and liabilities which cannot be allocated to any of the business segment are shown as unallocable assets/liabilities.

## Inter segment transfer:

There is no change in the nature of business of the Company during the year under review. The Company has two major business segments in terms of the nature of output (i) Fused Aluminium Oxide Grains including Calcined Products and Refractories Monolithic and (ii) Electricity (Power Division). Inter segment revenues are recognised at sales price. The same is based on market price and business risks. Profit or loss on inter segment transfer are eliminated at the group level.

#### **Financial Highlights & Accounting Treatment:**

The Financial Statements for the year ended 31<sup>st</sup> March, 2023, have been prepared in accordance with the Companies (Indian Accounting Standards) Rule, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other recognised



accounting practices and policies to the extent applicable.

During the year under review the revenue from operations of the Company stood at Rs. 28,384.93 Lakhs and gross profit & net profit stood at Rs. 1589.48 Lakhs & Rs. 1262.67 Lakhs respectively. Revenue and profit before tax increased vis-a-vis compared to previous financial year is mostly attributable to the partial commencement of activities at the Porbandar Plant as well as change in product mix. In Porbandar plant, the Company continued to produce and trade in other fused products, where specialised grade raw bauxite is not required. Through technical expertise, the Company continues to focus more on the manufacturing activities and value-added products compared to mining and related activities. During the year under review, gross revenue from sale of power (wind energy) stood at Rs. 690.71 Lakhs.

#### Dividend:

The Board has recommended dividend of Rs.0.25/- per equity share for the Financial Year ended 31st March, 2023, payable subject to approval of the Members at the ensuing Annual General Meeting. This will result in a total outflow of Rs. 299.10 Lakhs.

The Company believes in maintaining a fair balance between dividend distribution and cash retention. The cash retention is required for future growth, probable acquisitions and to meet any unforeseen contingencies.

The Whole-Time Director /Managing Director makes a declaration at each Board Meeting on quarterly basis, regarding the compliance with provisions of various statutes after obtaining confirmation from all the unit heads of the Company. The Company Secretary also ensures compliance, *inter-alia*, with the provisions of Companies Act, 2013 and SEBI Regulations.

## How our audit addressed the key audit matter

# 1. Overdue statutory payables – Royalty, contribution to District Mineral Fund (DMF) and Contribution to National Mineral Exploration Trust (NMET)

The Company is liable to pay royalty liability on dispatch of extracted material from its mines. The Company is also required to make contribution to District Mineral Fund (DMF) and National Mineral Exploration Trust (NMET) as per various government notification in this regard.

The Company has received demand letter dated August 16, 2018 from the Office of DMF and the Geology and Mining Department (District Mineral Foundation (Cell)) against the unpaid contribution and interest thereof with respect to the dispatch of bauxite ores from mines. The Company has filed petition against such demand which is pending in the Honorable Gujarat High Court and the management believes that the decision will come in favor of the Company.

The Company has also received orders from department of Udyog and Khan, Gandhinagar up to March, 2018 with respect to LME based royalty refund (net of payable) of Rs. 129 lakhs. The refund is not yet received by the Company.

As at year end, the Company is carrying liability in its books of Rs. 216.26 lakhs in respect of royalty and other contributions against which there is an advance payment of Rs. 128.21 lakhs as at March 31, 2023. The liability amount includes contribution payable for past 1-5 years as per the books.

- We have verified the relevant records of the Company's obligation with respect of Royalty, NMET and DMF;
- We have discussed the Company's policy regarding deposit of Royalty, NMET and DMF dues and as per management representation, the royalty is deposited in advance at the rate prescribed by Commissioner of Geology and Mining (CGM), whereas the royalty payable in the books of accounts is on account of difference between the rates prescribed by CGM and Indian Bureau of Mines (IBM).
- The management informed that the Company has also filed petition with honorable High Court of Gujarat against the demand letter from the Office of District Mineral Foundation and the Geology and Mining Department (District Mineral Foundation (Cell)) as the Company is of the view that the contribution is on production of bauxite ores after applicability of law w.e.f. September 16, 2015 instead of dispatch of bauxite ores from mines which were extracted before September 16, 2015.
- With respect to net refund orders received from department of Udyog and Khan, Gandhinagar, the Company will account for the same on receipt of such amount on the principles of prudence.
- We have ensured completeness of liabilities and relied on management representation as regards compliance of the Acts/notifications.

#### 2. Advance given to mining contractors pending adjustment

The Company extracts raw bauxite from its mines which are taken on lease. The company get the raw bauxite extracted through various sub-contractors which includes extraction, sizing, sorting, truck loading activities, etc. at various mines.

The Company accounts for the inventories of raw bauxite in the books when all the activities of the subcontractors get completed and material is readily usable.

As at March 31, 2023, the extracted stock of raw bauxite which remain to be sorted and weighment thereof is not recorded in the books.

Against the contracted activities which are currently in progress, the Company has outstanding advance of Rs. 897.07 lakhs as at reporting date paid to subcontractors towards various activities at mines.

Treatment of amount paid to sub-contractor as an advance pending adjustment, was determined to be key matter in our audit of the standalone financial statements.

- We have reviewed the Company's internal control as regards accounting of advance to sub-contractors and accounting of purchase of material.
- As per contractors' confirmation and management representation, at the reporting year end, as mining activities are in progress and hence, the amount paid to the contractors are treated as advances since the mining services obligations are not yet completed.
- We have also verified the amount of advance settled during the year based on receipt of raw bauxite and details of additional advance paid during the year



#### 3. Impairment of manufacturing plant at Porbandar

The Company's operations have been affected by non-availability of core raw material – specialized grade raw bauxite.

The Company has partially suspended the plant operations in respect of products manufactured from specialized grade raw bauxite at its Porbandar manufacturing plant.

The management is taking care of plant equipment health through periodic maintenance activities to keep the plant in working condition.

The net block of the property, plant and equipment at Porbandar plant is Rs. 6,694.68 lakhs as at March 31, 2023.

Our audit procedures in relation to evaluation of impairment testing of the manufacturing plant at Porbandar included the following:

- Performing test of controls over key financial controls related to accounting, valuation and recoverability of assets through inspection of evidence.
- Performing substantive audit procedures including:
- Obtaining the management's impairment assessment:
- Evaluating the key assumptions including projected revenue, weighted average cost of capital by comparing them with external data, where available;
- Obtaining and evaluating the sensitivity analysis.

## Information Other than the Standalone Financial Statements and Auditor's Report Thereon

The Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Board's Report including Annexures to Board's Report, Management Discussion and Analysis, Corporate Governance Report, Shareholder's Information, but does not include the standalone financial statements and auditor's report thereon. The Board's Report and other information are expected to be made available to us after the date of this auditor's report.

Our opinion on the standalone financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the standalone financial statements, our responsibility is to read the other information identified above when it becomes available and, in doing so, consider whether the other information is materially inconsistent with the standalone financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

When we read the aforesaid reports and information, if we conclude that there is material misstatement therein, we are required to communicate the matter to those charged with governance.

#### Management's Responsibility for the Standalone Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Act with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance including other comprehensive income, changes in equity and cash flows of the Company in accordance with the Ind AS and accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the standalone financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concerns and using the going concern basis of



accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors is also responsible for overseeing the Company's financial reporting process.

## Auditors' Responsibility for the Audit of the Standalone Financial Statements

## Notes forming part of the financial statements for the year ended 31st March 2023

#### **COMPANY INFORMATION**

Orient Abrasive Limited ("the Company") is a public limited company domiciled in India and incorporated on 12<sup>th</sup> November, 1971 under the provisions of the Companies Act vide CIN: L24299MH1971PLC366531 applicable in India. The Company is principally engaged in the business of production and trading of aluminum refractories and monolithics products, mining of bauxite ores and generation of power (including windmill facilities). The Company's manufacturing facilities are located at Porbandar (Gujarat) along with thermal power generation, bauxite mines located at various sites in Gujarat and windmill facilities in the state of Rajasthan and Karnataka. The registered office of the Company is located at Lawrence & Mayo House, 3<sup>rd</sup> Floor, 276, D.N Road, Fort, Mumbai - 400001. The equity shares of the Company are listed on Bombay Stock Exchange (BSE) as well as National Stock Exchange (NSE).

The standalone financial statements ('the financial statements") were authorized for issue in accordance with the resolution of the Board of Directors on 22<sup>nd</sup> May, 2023.

### BASIS OF PREPARATION, MEASUREMENT AND SIGNIFICANT ACCOUNTING POLICIES

#### 1.1 Basis of preparation and measurement:

These financial statements are the separate financial statements of the Company (also called standalone financial statements) prepared in accordance with the Indian Accounting Standards ('Ind AS') notified under section 133 of the Companies Act, 2013 ("the Act"), read together with the Companies (Indian Accounting Standards) Rules, 2015, as applicable.

These financial statements have been prepared and presented under the historical cost convention, on the accrual basis of accounting except for certain financial assets and financial liabilities that are measured at fair values at the end of each reporting period, as stated in the accounting policies set out below. The accounting policies have been applied consistently over all the periods presented in these financial statements.

All assets and liabilities have been classified as current or non current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Act. The Company considers 12 months as normal operating cycle.

The Company's financial statements are reported in Indian Rupees, which is also the Company's functional currency, and all values are rounded to the nearest lakhs except otherwise indicated.

## 1.2 <u>Significant accounting policies:</u>

### a. System of accounting

The financial statements of the Company are prepared in accordance with Indian Accounting Standards (Ind AS), under the historical cost convention on the accrual basis as per the provisions of Companies Act, 2013 ("Act"), except in case of significant uncertainties.

The Company presents assets and liabilities in the balance sheet based on current/non-current classification. It is held primarily for the purpose of being traded:

It is expected to be settled in the Company's normal operating cycle;

It is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least 12 months after the reporting date.

It is held primarily for the purpose of being traded;

There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.



Deferred tax assets and liabilities are classified as non-current only.

#### b. Key accounting estimates

The preparation of the financial statements, in conformity with the recognition and measurement principles of Ind AS, requires the management to make estimates and assumptions in the application of accounting policies that affect the reported amounts of assets, liabilities, income, expenses and disclosure of contingent liabilities as at the date of financial statements and the results of operation during the reported period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates which are recognised in the period in which they are determined.

The Company based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Company. Such changes are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

Estimates and judgements are regularly revisited. Estimates are based on historical experience and other factors, including futuristic reasonable information that may have a financial impact on the Company.

#### c. Property, plant and equipment

- (i) Property, plant and equipment are stated at historical cost of acquisition including attributable interest and finance costs, if any, till the date of acquisition/installation of the assets less accumulated depreciation and accumulated impairment losses, if any.
- (ii) Subsequent expenditure relating to property, plant and equipment is capitalised only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance costs are charged to the statement of profit and loss as incurred.
- (iii) The cost and related accumulated depreciation are eliminated from the financial statements, either on disposal or when retired from active use and the resultant gain or loss are recognised in the statement of profit and loss.
- (iv) Capital work-in-progress, representing expenditure incurred in respect of assets under development and not ready for their intended use, are carried at cost. Cost includes related acquisition expenses, construction cost, related borrowing cost and other direct expenditure.
- (v) The Company depreciates property, plant and equipment on written down value method except for building, plant & machinery, laboratory equipment and excavators where depreciation is provided on straight line method over the estimated useful life prescribed in Schedule II of the Act from the date the assets are ready for intended use after considering the residual value.
- (vi) Intangible assets mainly represent implementation cost for software and other application software acquired/developed for in-house use. These assets are stated at cost. Cost includes related acquisition expenses, related borrowing costs, if any, and other direct expenditure.
- (vii) Items of stores and spares that meet the definition of property, plant and equipment are capitalized at cost and depreciated over their useful life. Otherwise, such items are classified as inventories.
- (viii) Losses arising from the retirement of and gains or losses arising from disposal of property, plant and equipment which are carried at cost are recognised in the Statement of Profit and Loss.
- (ix) Property, plant and equipment and intangible assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units).



#### d. <u>Investments and financial assets</u>

#### (i) <u>Investments in subsidiaries</u>

Investments in subsidiaries are recognised at cost and not adjusted to fair value at the end of each reporting period. Cost represents amount paid for acquisition of the said investments.

The Company assesses at the end of each reporting period, if there is any indication that the said investments may be impaired. If so, the Company estimates the recoverable value of the investments and provides for impairment, if any, i.e. the deficit in the recoverable value over cost.

#### (ii) Financial assets

Financial assets are recognised when the Company becomes a party to the contractual provisions of the instrument.

On initial recognition, a financial asset is recognised at fair value, in case of financial assets which are recognised at fair value through profit and loss (FVTPL), its transaction costs are recognised in the statement of profit or loss. In other cases, the transaction costs are attributed to the acquisition value of financial asset. However, trade receivables that do not contain a significant financing component are measured at transaction price.

Financial assets are subsequently classified measured at -

- amortised cost
- fair value through profit and loss (FVTPL)
- fair value through other comprehensive income (FVOCI).

Financial assets are not reclassified subsequent to their recognition except if and in the period the Company changes its business model for managing financial assets.

Financial asset is derecognised only when the Company has transferred the rights to receive cash flows from the financial asset. Where the entity has transferred the asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, financial asset is derecognised.

In accordance with Ind AS 109, the Company applies the expected credit loss ("ECL") model for measurement and recognition of impairment loss on financial assets and credit risk exposures. The Company follows 'simplified approach' for recognition of impairment loss allowance on trade receivables. Simplified approach does not require the Company to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime ECL at each reporting date, right from its initial recognition. For recognition of impairment loss on other financial assets and risk exposure, the Company determines that whether there has been a significant increase in the credit risk since initial recognition.

#### e. <u>Inventories</u>

- (i) Raw materials and stores and spares are valued at weighted average cost including all charges in bringing the materials to the present location.
- (ii) Finished and semi-finished goods are valued at the cost plus direct expenses and appropriate value of overheads or net realizable value, whichever is lower.
- (iii) Obsolete, slow moving and defective inventories are written off/valued at net realisable value during the year as per policy consistently followed by the Company.

#### f. Cash and bank balances

#### **Cash and equivalents:**

Cash and cash equivalents in the balance sheet comprises of balance with banks and cash on hand and short term deposits with an original maturity of three month or less, which are subject to insignificant risks of changes in value.



#### Other bank balances:

Other bank balances include deposits with maturity less than twelve months but greater than three months and balances and deposits with banks that are restricted for withdrawal and usage.

#### g. Trade receivables

A receivable is classified as a trade receivable if it is in respect of the amount due on account of goods sold or services rendered in the normal course of business. Trade receivables are recognised initially at their transaction price and subsequently measured net of any expected credit losses.

#### h. Equity instruments:

An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments which are issued for cash are recorded at the proceeds received, net of direct issue costs.

#### i. Financial liabilities

- (i) Financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortised cost unless at initial recognition, they are classified as fair value through profit and loss.
- (ii) Financial liabilities are subsequently measured at amortised cost using the Effective Interest Rate (EIR) method. Financial liabilities carried at fair value through profit and loss are measured at fair value with all changes in fair value recognised in the statement of profit and loss.
- (iii) Financial liabilities are derecognised when the obligation specified in the contract is discharged, cancelled or expires.

## j. Trade payables

A payable is classified as a trade payable if it is in respect of the amount due on account of goods purchased in the normal course of business. These amounts represent liabilities for goods provided to the Company prior to the end of the financial year which are unpaid. These amounts are unsecured and are usually settled as per the payment terms. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period.

#### k. Revenue recognition

- (i) Revenue shall be recognised to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services.
- (ii) Revenue is measured based on transaction price, which is the fair value of the consideration received or receivable, stated net of discounts, return and goods & service tax. Transaction price is recognised based on the price specified in the contract, net of the estimated sales incentives/discounts.
- (iii) Accumulated experience is used to estimate and provide for the discounts/rights of return, using the expected value method.
- (iv) A return liability is recognised to expected return in relation to sales made corresponding assets are recognised for the products expected to be returned.
- (v) The Company recognises as an asset, the incremental costs of obtaining a contract with a customer, if the Company expects to recover those costs. The said asset is amortised on a systematic basis consistent with the transfer of goods or services to the customers.



- (vi) Export incentives are accounted for on export of goods if the entitlements can be estimated with reasonable accuracy and conditions precedent to claim are reasonably expected to be fulfilled.
- (vii) Revenue in respect of other income is recognised on accrual basis. However, where the ultimate collection of the same lacks reasonable certainty, revenue recognition is postponed to the extent of uncertainty.

#### l. Indirect taxes

Purchases of goods and fixed assets are accounted for net of Goods and Service Tax (GST) input credits. Custom duty paid on import of materials is dealt with in respective material accounts.

#### m. Mining expenses

Expenses incurred on mining including removal of overburden of mines are charged to the statement of profit & loss as mining cost on the basis of quantity of minerals mined during the year, overburden of removal and mining being carried out concurrently and relatively within a short period of time. Mining restoration expenses are annually reviewed and provided for.

#### n. Foreign currency transactions

- (i) Items included in the financial statements are measured using the currency of primary economic environment in which the company operates ("the functional currency"). The financial statements are presented in Indian Rupee (INR), which is the company's functional and presentation currency.
- (ii) Foreign currency transactions are initially recorded in the reporting currency at foreign exchange rate on the date of the transaction.
- (iii) Monetary items of current assets and current liabilities denominated in foreign currencies are reported using the closing rate at the reporting date. Non-monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of the transaction.
- (iv) The gain or loss on decrease/increase in reporting currency due to fluctuations in foreign exchange rates are recognised in the statement of profit or loss.

#### o. Employee benefit expenses

- (i) Contributions to defined contribution schemes such as provident fund, employees' state insurance, labour welfare fund etc. are charged as an expense based on the amount of contribution required to be made as and when services are rendered by the employees. These benefits are classified as defined contribution schemes as the Company has no further obligations beyond the monthly contributions.
- (ii) The Company provides for gratuity which is a defined benefit plan, the liabilities of which are determined based on valuations, as at the reporting date, made by an independent actuary using the projected unit credit method. Re-measurement comprising of actuarial gains and losses, in respect of gratuity are recognised in the other comprehensive income in the period in which they occur. The classification of the Company's obligation into current and non-current is as per the actuarial valuation report.
- (iii) The employees are entitled to accumulate leave subject to certain limits, for future encashment and availment, as per the policy of the Company. The liability towards such unutilised leave as at the end of each balance sheet date is determined based on independent actuarial valuation and recognised in the statement of profit and loss.

#### p. <u>Leases</u>

The Company, as a lessee, recognises a right-of-use asset and a lease liability for its leasing arrangements, if the contract conveys the right to control the use of an identified asset.

The contract conveys the right to control the use of an identified asset, if it involves the use of an identified asset and the Company has substantially all of the economic benefits from use of the asset and has right to direct the use of the identified

asset. The cost of the right-of-use asset shall comprise of the amount of the initial measurement of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred. The right-of-use assets is subsequently measured at cost less any accumulated depreciation, accumulated impairment losses, if any and adjusted for any remeasurement of the lease liability. The right-of-use assets is depreciated using the straight-line method from the commencement date over the shorter of lease term or useful life of right-of-use asset.

The Company applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (i.e., those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of office equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

#### q. Borrowing costs

Borrowing costs consist of interest and other costs that the Company incurs in connection with the borrowing of funds. Also, the effective interest rate amortisation is included in finance costs. Borrowing costs relating to acquisition, construction or production of a qualifying asset which takes substantial period of time to get ready for its intended use are added to the cost of such asset to the extent they relate to the period till such assets are ready to be put to use. All other borrowing costs are expensed in the statement of profit and loss in the period in which they occur.

### r. Impairment of non financial assets

As at each reporting date, the Company assesses whether there is an indication that a non-financial asset may be impaired and also whether there is an indication of reversal of impairment loss recognised in the previous periods. If any indication exists, or when annual impairment testing for an asset is required, the Company determines the recoverable amount and impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. If the amount of impairment loss subsequently decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, then the previously recognised impairment loss is reversed through the statement of profit and loss.

#### s. Taxes on income

Income tax expense comprises current tax expense and the deferred tax during the year. Current and deferred taxes are recognised in the statement of profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity, respectively.

Current income tax is recognised based on the estimated tax liability computed after taking credit for allowances and exemptions in accordance with the Income Tax Act, 1961. Current income tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit.

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognized for unused tax losses, unused tax credits and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which they can be used. In case of uncertainty of reversal of the deferred tax assets or when it is no longer probable that sufficient taxable profits will be available in the foreseeable future, deferred tax assets, as a matter of prudence, are not recognised.

The carrying amount of deferred tax is reviewed at each reporting date and measured at the tax rates that are expected to be applied to temporary differences when they reverse, using tax rates enacted or substantively enacted at the reporting date. The measurement of deferred tax reflects the tax consequences that would follow from the manner in which the Company expects, at the reporting date, to recover or settle the carrying amount of its assets and liabilities.

#### t. Provisions and contingent liabilities

The Company creates a provision when there is present obligation, legal or constructive, as a result of past events that



probably requires an outflow of resources and a reliable estimate can be made of the amount of obligation.

Contingent liabilities are disclosed in respect of possible obligations that arise from past events, whose existence would be confirmed by the occurrence or non-occurrence of one or more uncertain future events. Contingent assets are neither recognised nor disclosed in the financial statements.

#### u. Earnings per share

- (I) Basic earnings per share is computed by dividing the net profit or loss for the period attributable to the equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period and for all periods presented is adjusted for events, such as bonus shares, other than the conversion of potential equity shares that have changed the number of equity shares outstanding, without a corresponding change in resources.
- (ii) For the purpose of calculating diluted earning per share, the net profit or loss for the period attributable to the equity shareholders and the weighted average number of equity shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

## v. Offsetting instruments

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Company or the counterparty.

#### w. Events after the reporting period

Adjusting events are events that provide further evidence of conditions that existed at the end of the reporting period. The financial statements are adjusted for such events before authorisation for issue. Non-adjusting events are events that are indicative of conditions that arose after end of the reporting period. Non-adjusting events after the reporting date are not accounted, but disclosed.

#### x. Cash dividend to equity holders of the Company

The Company recognises a liability to make cash or non-cash distributions to equity holders of the Company when the distribution is authorised and the distribution is no longer at the discretion of the Company. As per the corporate laws in India, a distribution is authorised when it is approved by the shareholders. A corresponding amount is recognised directly in equity.

#### y. Segment reporting

#### **Business Segment**

The chief operational decision maker (CODM) monitors the operating results of its business segment separately for the purpose of making decision about resource allocation and performance assessment. Segment performance is evaluated based on profit or loss and is measured consistently with profit or loss in the financial statements, Operating segment have been identified on the basis of nature of products and other quantitative criteria specified in the Ind AS 108. The analysis of geographical segments is based on the areas in which major operating divisions of the Company operate.

#### **Intersegment Transfers**

The Company generally accounts for intersegment sales and transfers as if the sales or transfers were to third parties at current market prices.



#### Allocation of common costs

Common allocable costs are allocated to each segment according to the relative contribution of each segment to the total common costs.

#### **Segment Policies**

The Company prepares segment information in conformity with the accounting policies adopted for preparing and presenting the financial statements of the Company as a whole.

z. Recent pronouncements, the Ministry of Corporate Affairs has vide notification dated 31st March, 2023 notified Companies (Indian Accounting Standards) Amendment Rules, 2023 (the 'Rules') which amends certain accounting standards, and are effective 1 April 2023. The Rules predominantly amends Ind AS 1, Presentation of financial statements and Ind AS 12, Income taxes, whereas the other amendments notified by these rules are primarily in the nature of clarifications. The impact of the amendment on the Financial Statements is expected to be insignificant on the basis of the preliminary evaluation.

The Board provides guiding principles for overall risk management as well as policies covering specific areas such as foreign exchange risk, credit risk and investment of surplus liquidity.

#### A. Credit risk

Credit risk refers to the risk of a counter party default on its contractual obligation resulting into a financial loss to the Company. The maximum exposure of the financial assets represents trade receivables, work in progress and receivables from group companies and others.

Customer credit risk is managed by the Company through established policy and procedures and control relating to customer credit risk management. Trade receivables are non-interest bearing and are generally carrying upto 90 days credit terms. The Company has a detailed review mechanism of overdue customer receivables at various levels within organisation to ensure proper attention and focus for realisation. Trade receivables are consisting of a large number of customers. Export receivables are backed by forward contract. In respect of trade receivables, the Company uses a provision matrix to compute the expected credit loss allowances for trade receivables in accordance with the excepted credit loss (ECL) policy of the Company.

## B. Liquidity risk

Liquidity risk is the risk that the Company will encounter difficulty in raising funds to meet its commitments associated with financial instruments. Liquidity risk may result from an inability to sell a fianncial aseets quickly at close to its fair value.

The Company manages liquidity risk by maintaining adequate reserves and banking facilities by continuously monitoring forcast and actual cash flows and by matching the maturity profiles of financial assets and liabilities.

#### C. Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Such changes in the values of financial instruments may result from changes in foreign currency exchange rates, interest rates, credit, liquidity and other market changes.

The Company has several balances in foreign currency and consequently, the Company is exposed to foreign exchange risk. The Company evaluates exchange rate exposure arising from foreign currency transactions and follows established risk management policies.

#### a) Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long-term debt obligations with floating interest rates. The Company manages its interest rate risk by having a balanced portfolio of fixed and variable rate loans and borrowings.

#### b) Interest rate sensitivity:

#### Note 39 Segment reporting

For management purposes, the Company is organised into business units based on its products and services and has two reportable segments, as follows:

- a) Alumina Refactories & Monolithics products & bauxite ores: Alumina Refactories & Monolithics products manufactures calcined bauxite, fused aluminium oxide abrasive grains and low cement castables which are mainly consumed in steel plants. Plant grade bauxite ores are captively consumed at the plant and Non plant grade bauxite ores are sold in the market
- b) Power generation: The Company has a thermal power plant, furnace oil based power plant and windmills. Power generated from thermal power plant and furnace oil based power plant is captively consumed at the plant and power generated from windmills is sold to the respective state power distribution companies.

No operating segments have been aggregated to form the above reportable operating segments.

The Executive Management Committee monitors the operating results of its business units separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on profit or loss and is measured consistently with profit or loss in the financial statements. The Company's financing (including finance costs and finance income) and income taxes are managed on a Company basis and are not allocated to operating segments.

Transfer prices between operating segments are on an arm's length basis in a manner similar to transactions with third parties.

#### Report on the Consolidated Financial Statements

#### **Opinion**

We have audited the accompanying consolidated financial statements of **Orient Abrasives Limited** ("the Parent Company") and its wholly-owned subsidiaries (the Parent Company and its subsidiaries together referred to as "the Group"), which comprise the Consolidated Balance Sheet as at 31<sup>st</sup> March 2023, the consolidated statement of profit and loss including other comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended and notes to the consolidated financial statements, a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the consolidated financial statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid consolidated financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, ('Ind AS") and the other accounting principles generally accepted in India, of the consolidated state of affairs of the Group as at 31st March 2023, of its consolidated profit including total comprehensive income, consolidated changes in equity and consolidated cash flows for the year ended on that date.

#### **Basis for Opinion**

We conducted our audit of the consolidated financial statements in accordance with the Standards on Auditing (SAs) specified under Section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("the ICAI") together with the ethical requirements that are relevant to our audit of the consolidated financial statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion on the consolidated financial statements.

## **Key audit matters**

Key audit matters are those matters which, in our professional judgment were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in our forming our opinion thereon, and we do not provide a separate opinion on these matters. We have the matters described below to be the key audit matters to be communicated in our report:



#### **Key audit matters**

## How our audit addressed the key audit matter

# 1. Overdue statutory payables – Royalty, contribution to District Mineral Fund (DMF) and Contribution to National Mineral Exploration Trust (NMET)

The Parent Company is liable to pay royalty liability on dispatch of extracted material from its mines. The Parent Company is also required to make contribution to District Mineral Fund (DMF) and National Mineral Exploration Trust (NMET) as per various government notification in this regard.

The Parent Company has received demand letter dated August 16, 2018 from the Office of DMF and the Geology and Mining Department (District Mineral Foundation (Cell)) against the unpaid contribution and interest thereof with respect to the dispatch of bauxite ores from mines. The Parent Company has filed petition against such demand which is pending in the Honorable Gujarat High Court and the management believes that the decision will come in favor of the Parent Company.

The Parent Company has also received orders from department of Udyog and Khan, Gandhinagar up to March, 2018 with respect to LME based royalty refund (net of payable) of Rs. 129 lakhs. The refund is not yet received by the Parent Company.

As at year end, the Parent Company is carrying liability in its books of Rs. 216.26 lakhs in respect of royalty and other contributions against which there is an advance payment of Rs. 128.21 lakhs as at March 31, 2023. The liability amount includes contribution payable for past 1-5 years as per the books.

- We have verified the relevant records of the Parent Company's obligation with respect of Royalty, NMET and DMF;
- We have discussed the Parent Company's policy regarding deposit of Royalty, NMET and DMF dues and as per management representation, the royalty is deposited in advance at the rate prescribed by Commissioner of Geology and Mining (CGM), whereas the royalty payable in the books of accounts is on account of difference between the rates prescribed by CGM and Indian Bureau of Mines (IBM).
- The management informed that the Parent Company has also filed petition with honorable High Court of Gujarat against the demand letter from the Office of District Mineral Foundation and the Geology and Mining Department (District Mineral Foundation (Cell)) as the Parent Company is of the view that the contribution is on production of bauxite ores after applicability of law w.e.f. September 16, 2015 instead of dispatch of bauxite ores from mines which were extracted before September 16, 2015.
- With respect to net refund orders received from department of Udyog and Khan, Gandhinagar, the Parent Company will account for the same on receipt of such amount on the principles of prudence.
- We have ensured completeness of liabilities and relied on management representation as regards compliance of the Acts/notifications.

#### 2. Advance given to mining contractors pending adjustment

The Parent Company extracts raw bauxite from its mines which are taken on lease. The Parent Company get the raw bauxite extracted through various sub-contractors which includes extraction, sizing, sorting, truck loading activities, etc. at various mines.

The Parent Company accounts for the inventories of raw bauxite in the books when all the activities of the sub-contractors get completed and material is readily usable.

As at March 31, 2023, the extracted stock of raw bauxite which remain to be sorted and weighment thereof is not recorded in the books.

Against the contracted activities which are currently in progress, the Company has outstanding advance of Rs. 897.07 lakhs as at reporting date paid to sub-contractors towards various activities at mines.

Treatment of amount paid to sub-contractor as an advance pending adjustment, was determined to be key matter in our audit of the standalone financial statements.

- We have reviewed the Parent Company's internal control as regards accounting of advance to sub-contractors and accounting of purchase of material.
- As per contractors' confirmation and management representation, at the reporting year end, as mining activities are in progress and hence, the amount paid to the contractors are treated as advances since the mining services obligations are not yet completed.
- We have also verified the amount of advance settled during the year based on receipt of raw bauxite and details of additional advance paid during the year.



#### 3. Impairment of manufacturing plant at Porbandar

The Parent Company's operations have been affected by non-availability of core raw material – specialized grade raw bauxite.

The Parent Company has partially suspended the plant operations in respect of products manufactured from specialized grade raw bauxite at its Porbandar manufacturing plant.

The management is taking care of plant equipment health through periodic maintenance activities to keep the plant in working condition.

The net block of the property, plant and equipment at Porbandar plant is Rs. 6,694.68 lakhs as at March 31, 2023.

Our audit procedures in relation to evaluation of impairment testing of the manufacturing plant at Porbandar included the following:

- Performing test of controls over key financial controls related to accounting, valuation and recoverability of assets through inspection of evidence.
- Performing substantive audit procedures including:
  - Obtaining the management's impairment assessment;
  - Evaluating the key assumptions including projected revenue, weighted average cost of capital by comparing them with external data, where available;
- Obtaining and evaluating the sensitivity analysis.

#### Information Other than the Consolidated Financial Statements and Auditor's Report Thereon

The Parent Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Board's Report including Annexures to Board's Report, Management Discussion and Analysis, Shareholder's Information, but does not include the consolidated financial statements and auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

When we read the aforesaid reports and information, if we conclude that there is material misstatement therein, we are required to communicate the matter to those charged with governance.

#### Management's Responsibility for the Consolidated Financial Statements

The Parent Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Act with respect to the preparation of these consolidated financial statements that give a true and fair view of the consolidated financial position, consolidated financial performance including other comprehensive income, consolidated changes in equity and consolidated cash flows of the Group in accordance with the Ind AS and accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Group and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the consolidated financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the consolidated financial statements by the Directors of the Parent Company, as aforesaid.

In preparing the consolidated financial statements, the respective Board of Directors of the companies included in the Group are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.

The respective Board of Directors of the companies included in the Group are also responsible for overseeing financial reporting process of the Group.



#### Auditor's Responsibility for the Audit of the Consolidated Financial Statements

Our objectives are to obtain reasonable assurance about whether the consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is high level of assurance, but is not a guarantee that audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatements of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of the internal control.

Under section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the Company has adequate internal financial controls system in place and the operating effectiveness of such controls.

- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the ability of the Group to continue as going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Group to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosure, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision and performance of the audit of the financial statements of such entities or business activities included in the consolidated financial statements of which we are the independent auditors.

We communicate with those charged with governance of the Parent Company regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

#### **Other Matters**

We did not audit the financial statements of one subsidiary company whose financial statements reflect total assets of Rs. 7.83 lakhs as at 31<sup>st</sup> March 2023 and gross total revenues of Nil and net loss after tax (including other comprehensive income) Rs. 12.12 lakhs for the year then ended as considered in the consolidated financial statements. These financial statements and other financial information have been audited by other auditors whose reports have been furnished to us by the management, and our opinion on consolidated financial results, in so far as it relates to the amounts and disclosures included in respect of this subsidiary company is based solely on the report of such other auditors.

Our opinion on the consolidated financial statements above and our report on other Legal and Regulatory Requirements below is not modified in respect of these matters with respect to our reliance on the work done and the reports of the other auditors.

#### Report on Other Legal and Regulatory Requirements

1. With respect to the matters specified in clause (xxi) of paragraph 3 and paragraph 4 of the Companies (Auditor's Report) Order, 2020 ("CARO/"the Order") issued by the Central Government in terms of Section 143(11) of the Act, according to the information and explanations given to us, and based on the CARO reports issued by us included in the consolidated financial statements to which reporting under CARO is applicable, as provided to us by the Management of the Parent Company, we report that there are no qualifications or adverse remarks by the respective auditors in the CARO reports of the said respective companies included in the consolidated financial statements except following:

#### Notes forming part of the consolidated financial statements for the year ended 31st March 2023

#### **GROUP INFORMATION**

**Orient Abrasive Limited** ("the Group") is a public limited Group domiciled in India and incorporated on 12<sup>th</sup> November, 1971 under the provisions of the Companies Act vide CIN: L24299MH1971PLC366531 applicable in India. The Group is principally engaged in the business of production and trading of aluminum refractories and monolithics products, mining of bauxite ores and generation of power (including windmill facilities). The Group's manufacturing facilities are located at Porbandar (Gujarat) along with thermal power generation, bauxite mines located at various sites in Gujarat and windmill facilities in the state of Rajasthan and Karnataka. The registered office of the Group is located at Lawrence & Mayo House, 3<sup>rd</sup> Floor, 276, D.N Road, Fort, Mumbai – 400 001. The equity shares of the Group are listed on Bombay Stock Exchange (BSE) as well as National Stock Exchange (NSE).

The consolidated financial statements ('the financial statements'') were authorized for issue in accordance with the resolution of the Board of Directors on 22<sup>nd</sup> May, 2023.

## 1 BASIS OF PREPARATION, MEASUREMENT AND SIGNIFICANT ACCOUNTING POLICIES

#### 1.1 Basis of preparation and measurement:

These consolidated financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'Ind AS') as notified by Ministry of Corporate Affairs pursuant to section 133 of the Companies Act, 2013 ("the Act") read together with Companies (Indian Accounting Standards) Rules, 2015, as applicable.

The consolidated financial statements have been prepared and presented under historical cost convention, on accrual basis of accounting except for certain financial assets and financial liabilities that are measured at fair value at the end of each reporting period, as stated in the accounting policies set out below. The accounting policies have been applied consistently over all the periods presented in these consolidated financial statements.

All assets and liabilities have been classified as current or non current as per the Group's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Act. The Group considers 12 months as normal operating cycle.

Consolidated Financial Statements are presented in Indian Rupees (INR) which is the Group Group's functional currency, and all the values are rounded to the nearest lakhs except otherwise indicated.

#### 1.2 **Basis for consolidation**

- a. The consolidated financial statements are prepared using uniform accounting policies for like transactions and other events in similar circumstances. If a member of the group uses accounting policies other than those adopted in the consolidated financial statements, appropriate adjustments are made to that group member's financial statements in preparing the consolidated financial statements to ensure conformity with the group's accounting policies.
- b. The financial statements of all entities used for the purpose of consolidation are drawn up to same reporting date as that of the Parent Company. Where the end of the reporting period of the other group companies is different from that of the Parent Company, those companies prepare, for consolidation purpose, additional financial information as of the same date as the financial statements of the Parent Company to enable the Parent Company to consolidate the financial information of those companies, unless it is impracticable to do so.
- c. The consolidated financial statements present the consolidated accounts of Orient Abrasives Limited with its following subsidiaries:

#### d. Subsidiaries

- a) A subsidiary is an entity over which the Parent Company has control. The Parent Company controls an entity when the Parent Company is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the relevant activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Parent Company.
- b) The Parent Company combines the financial statements of the Parent Company and its subsidiary companies on a line by line basis, adding together like items of assets, liabilities, equity, income and expenses. Inter-Group transactions, balances and unrealized gains on transactions among the Group are eliminated. Unrealized losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries are consistent with the policies adopted by the Parent Company.
- c) A change in the ownership interest of a subsidiary, without loss of control, is accounted for as an equity transaction. If the Parent Company loses control over a subsidiary, it derecognizes the assets, liabilities, carrying amount of any non-controlling interests and the cumulative translation differences recorded in equity.

#### 1.3 Significant accounting policies:

#### a. System of accounting

The Group follows mercantile system of accounting and recognises income and expenditure on an accrual basis except in case of significant uncertainties. These financial statements are prepared under the historical cost convention unless otherwise indicated.

#### b. Key accounting estimates

The preparation of the financial statements, in conformity with the recognition and measurement principles of Ind AS, requires the management to make estimates and assumptions in the application of accounting policies that affect the reported amounts of assets, liabilities, income, expenses and disclosure of contingent liabilities as at the date of financial statements and the results of operation during the reported period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates which are recognised in the period in which they are determined.

The Group based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Group. Such changes are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

#### c. Current and Non-Current Classification

The Group presents assets and liabilities in the balance sheet based on current and non-current classification. Any asset or liability is classified as current if it satisfies any of the following conditions:

- It is expected to be settled in the Group's normal operating cycle;



- It is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least 12 months after the reporting date.
- It is held primarily for the purpose of being traded;
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.
- All other liabilities are classified as non-current.
- Deferred tax assets and liabilities are classified as non-current only.

#### d. Property, plant and equipment

- (i) Property, plant and equipment are stated at historical cost of acquisition including attributable interest and finance costs, if any, till the date of acquisition/installation of the assets less accumulated depreciation and accumulated impairment losses, if any.
- (ii) Subsequent expenditure relating to property, plant and equipment is capitalised only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are charged to the statement of profit and loss as incurred.
- (iii) The cost and related accumulated depreciation are eliminated from the financial statements, either on disposal or when retired from active use and the resultant gain or loss are recognised in the statement of profit and loss.
- (iv) Capital work-in-progress, representing expenditure incurred in respect of assets under development and not ready for their intended use, are carried at cost. Cost includes related acquisition expenses, construction cost, related borrowing cost and other direct expenditure.
- (v) The Group depreciates property, plant and equipment on written down value method except for building, plant & machinery, laboratory equipment and excavators where depreciation is provided on straight line method over the estimated useful life prescribed in Schedule II of the Act from the date the assets are ready for intended use after considering the residual value.
- (vi) Intangible assets mainly represent implementation cost for software and other application software acquired/developed for in-house use. These assets are stated at cost. Cost includes related acquisition expenses, related borrowing costs, if any, and other direct expenditure.
- (vii) Items of stores and spares that meet the definition of property, plant and equipment are capitalized at cost and depreciated over their useful life. Otherwise, such items are classified as inventories.
- (viii) Losses arising from the retirement of and gains or losses arising from disposal of property, plant and equipment which are carried at cost are recognised in the Statement of Profit and Loss.
- (ix) Property, plant and equipment and intangible assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units).

#### e. Financial assets

Financial assets are recognised when the Group becomes a party to the contractual provisions of the

instrument.

On initial recognition, a financial asset is recognised at fair value, in case of financial assets which are recognised at fair value through profit and loss (FVTPL), its transaction costs are recognised in the statement of profit or loss. In other cases, the transaction costs are attributed to the acquisition value of financial asset. However, trade receivables that do not contain a significant financing component are measured at transaction price.

Financial assets are subsequently classified measured at –

- amortised cost
- fair value through profit and loss (FVTPL)
- fair value through other comprehensive income (FVOCI).

Financial assets are not reclassified subsequent to their recognition except if and in the period the Group changes its business model for managing financial assets.

Financial asset is derecognised only when the Group has transferred the rights to receive cash flows from the financial asset. Where the entity has transferred the asset, the Group evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, financial asset is derecognised.

In accordance with Ind AS 109, the Group applies the expected credit loss ("ECL") model for measurement and recognition of impairment loss on financial assets and credit risk exposures. The Group follows 'simplified approach' for recognition of impairment loss allowance on trade receivables. Simplified approach does not require the Group to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime ECL at each reporting date, right from its initial recognition. For recognition of impairment loss on other financial assets and risk exposure, the Group determines that whether there has been a significant increase in the credit risk since initial recognition.

#### f. Inventories

- (i) Raw materials and stores and spares are valued at weighted average cost including all charges in bringing the materials to the present location.
- (ii) Finished and semi-finished goods are valued at the cost plus direct expenses and appropriate value of overheads or net realizable value, whichever is lower.
- (iii) Obsolete, slow moving and defective inventories are written off/valued at net realisable value during the year as per policy consistently followed by the Group.

#### g. Cash and bank balances

#### **Cash and equivalents:**

Cash and cash equivalents in the balance sheet comprises of balance with banks and cash on hand and short term deposits with an original maturity of three month or less, which are subject to insignificant risks of changes in value.

#### Other bank balances:

Other bank balances include deposits with maturity less than twelve months but greater than three months and balances and deposits with banks that are restricted for withdrawal and usage.

#### h. Trade receivables

A receivable is classified as a trade receivable if it is in respect of the amount due on account of goods sold or services rendered in the normal course of business. Trade receivables are recognised initially at their transaction price and subsequently measured net of any expected credit losses.

#### I. **Equity instruments:**

An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. Equity instruments which are issued for cash are recorded at the proceeds received, net of direct issue costs.

## j. Financial liabilities

- (i) Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortised cost unless at initial recognition, they are classified as fair value through profit and loss.
- (ii) Financial liabilities are subsequently measured at amortised cost using the Effective Interest Rate (EIR) method. Financial liabilities carried at fair value through profit and loss are measured at fair value with all changes in fair value recognised in the statement of profit and loss.
- (iii) Financial liabilities are derecognised when the obligation specified in the contract is discharged, cancelled or expires.

## k. Trade payables

A payable is classified as a trade payable if it is in respect of the amount due on account of goods purchased in the normal course of business. These amounts represent liabilities for goods provided to the Group prior to the end of the financial year which are unpaid. These amounts are unsecured and are usually settled as per the payment terms. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period.

# I. Revenue recognition

- (i) Revenue shall be recognised to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services.
- (ii) Revenue is measured based on transaction price, which is the fair value of the consideration received or receivable, stated net of discounts, return and goods & service tax. Transaction price is recognised based on the price specified in the contract, net of the estimated sales incentives/discounts.
- (iii) Accumulated experience is used to estimate and provide for the discounts/rights of return, using the expected value method.
- (iv) A return liability is recognised to expected return in relation to sales made corresponding assets are recognised for the products expected to be returned.
- (v) The Group recognises as an asset, the incremental costs of obtaining a contract with a customer, if the Group expects to recover those costs. The said asset is amortised on a systematic basis consistent with the transfer of goods or services to the customers.
- (vi) Export incentives are accounted for on export of goods if the entitlements can be estimated with reasonable accuracy and conditions precedent to claim are reasonably expected to be fulfilled.
- (vii) Revenue in respect of other income is recognised on accrual basis. However, where the ultimate collection of the same lacks reasonable certainty, revenue recognition is postponed to the extent of uncertainty.

# m. Indirect taxes

Purchases of goods and fixed assets are accounted for net of Goods and Service Tax (GST) input credits. Custom duty paid on import of materials is dealt with in respective material accounts.

# n. Mining expenses

Expenses incurred on mining including removal of overburden of mines are charged to the statement of profit & loss as mining cost on the basis of quantity of minerals mined during the year, overburden of removal and mining being carried out concurrently and relatively within a short period of time. Mining restoration expenses are annually reviewed and provided for.

#### o. Foreign currency transactions

- (i) Items included in the financial statements are measured using the currency of primary economic environment in which the Group operates ("the functional currency"). The financial statements are presented in Indian Rupee (INR), which is the Group's functional and presentation currency.
- (ii) Foreign currency transactions are initially recorded in the reporting currency at foreign exchange rate on the date of the transaction.
- (iii) Monetary items of current assets and current liabilities denominated in foreign currencies are reported using the closing rate at the reporting date. Non-monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of the transaction.
- (iv) The gain or loss on decrease/increase in reporting currency due to fluctuations in foreign exchange rates are recognised in the statement of profit or loss.

#### p. Employee benefit expenses

- (i) Contributions to defined contribution schemes such as provident fund, employees' state insurance, labour welfare fund etc. are charged as an expense based on the amount of contribution required to be made as and when services are rendered by the employees. These benefits are classified as defined contribution schemes as the Group has no further obligations beyond the monthly contributions.
- (ii) The Group provides for gratuity which is a defined benefit plan, the liabilities of which are determined based on valuations, as at the reporting date, made by an independent actuary using the projected unit credit method. Re-measurement comprising of actuarial gains and losses, in respect of gratuity are recognised in the other comprehensive income in the period in which they occur. The classification of the Group's obligation into current and non-current is as per the actuarial valuation report.
- (iii) The employees are entitled to accumulate leave subject to certain limits, for future encashment and availment, as per the policy of the Group. The liability towards such unutilised leave as at the end of each balance sheet date is determined based on independent actuarial valuation and recognised in the statement of profit and loss.

#### q. Leases

The Group, as a lessee, recognises a right-of-use asset and a lease liability for its leasing arrangements, if the contract conveys the right to control the use of an identified asset.

The contract conveys the right to control the use of an identified asset, if it involves the use of an identified asset and the Group has substantially all of the economic benefits from use of the asset and has right to direct the use of the identified asset. The cost of the right-of-use asset shall comprise of the amount of the initial measurement of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred. The right-of-use assets is subsequently measured at cost less any accumulated depreciation, accumulated impairment losses, if any and adjusted for any remeasurement of the lease liability. The right-of-use assets is depreciated using the straight-line method from the commencement date over the shorter of lease term or useful life of right-of-use asset.

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (i.e., those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of office

equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

#### r. Borrowing costs

Borrowing costs consist of interest and other costs that the Group incurs in connection with the borrowing of funds. Also, the effective interest rate amortisation is included in finance costs. Borrowing costs relating to acquisition, construction or production of a qualifying asset which takes substantial period of time to get ready for its intended use are added to the cost of such asset to the extent they relate to the period till such assets are ready to be put to use. All other borrowing costs are expensed in the statement of profit and loss in the period in which they occur.

# s. Impairment of non financial assets

As at each reporting date, the Group assesses whether there is an indication that a non-financial asset may be impaired and also whether there is an indication of reversal of impairment loss recognised in the previous periods. If any indication exists, or when annual impairment testing for an asset is required, the Group determines the recoverable amount and impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. If the amount of impairment loss subsequently decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, then the previously recognised impairment loss is reversed through the statement of profit and loss.

#### t. <u>Taxes on income</u>

Income tax expense comprises current tax expense and the deferred tax during the year. Current and deferred taxes are recognised in the statement of profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity, respectively.

Current income tax is recognised based on the estimated tax liability computed after taking credit for allowances and exemptions in accordance with the Income Tax Act, 1961. Current income tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit.

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognized for unused tax losses, unused tax credits and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which they can be used. In case of uncertainty of reversal of the deferred tax assets or when it is no longer probable that sufficient taxable profits will be available in the foreseeable future, deferred tax assets, as a matter of prudence, are not recognised.

The carrying amount of deferred tax is reviewed at each reporting date and measured at the tax rates that are expected to be applied to temporary differences when they reverse, using tax rates enacted or substantively enacted at the reporting date. The measurement of deferred tax reflects the tax consequences that would follow from the manner in which the Group expects, at the reporting date, to recover or settle the carrying amount of its assets and liabilities.

# u. Provisions and contingent liabilities

The Group creates a provision when there is present obligation, legal or constructive, as a result of past events that probably requires an outflow of resources and a reliable estimate can be made of the amount of obligation.

Contingent liabilities are disclosed in respect of possible obligations that arise from past events, whose existence would be confirmed by the occurrence or non-occurrence of one or more uncertain future events. Contingent assets are neither recognised nor disclosed in the financial statements.

#### v. Earnings per share

- (i) Basic earnings per share is computed by dividing the net profit or loss for the period attributable to the equity shareholders of the Group by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period and for all periods presented is adjusted for events, such as bonus shares, other than the conversion of potential equity shares that have changed the number of equity shares outstanding, without a corresponding change in resources.
- (ii) For the purpose of calculating diluted earning per share, the net profit or loss for the period attributable to the equity shareholders and the weighted average number of equity shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

#### w. Offsetting instruments

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Group or the counterparty.

#### x. Events after the reporting period

Adjusting events are events that provide further evidence of conditions that existed at the end of the reporting period. The financial statements are adjusted for such events before authorisation for issue. Non-adjusting events are events that are indicative of conditions that arose after end of the reporting period. Non-adjusting events after the reporting date are not accounted, but disclosed.

#### y. Cash dividend to equity holders of the Group

The Group recognises a liability to make cash or non-cash distributions to equity holders of the Group when the distribution is authorised and the distribution is no longer at the discretion of the Group. As per the corporate laws in India, a distribution is authorised when it is approved by the shareholders. A corresponding amount is recognised directly in equity.

#### z. Segment reporting

## **Business Segment**

The chief operational decision maker (CODM) monitors the operating results of its business segment separately for the purpose of making decision about resource allocation and performance assessment. Segment performance is evaluated based on profit or loss and is measured consistently with profit or loss in the financial statements, Operating segment have been identified on the basis of nature of products and other quantitative criteria specified in the Ind AS 108. The analysis of geographical segments is based on the areas in which major operating divisions of the Group operate.

# **Intersegment Transfers**

The Group generally accounts for intersegment sales and transfers as if the sales or transfers were to third parties at current market prices.

#### Allocation of common costs

Common allocable costs are allocated to each segment according to the relative contribution of each segment to the total common costs.

# **Segment Policies**

The Group prepares segment information in conformity with the accounting policies adopted for preparing and



presenting the financial statements of the Group as a whole.

Recent pronouncements, the Ministry of Corporate Affairs has vide notification dated 31<sup>st</sup> March, 2023 notified Companies (Indian Accounting Standards) Amendment Rules, 2023 (the 'Rules') which amends certain accounting standards, and are effective 1 April 2023. The Rules predominantly amends Ind AS 1, Presentation of financial statements and Ind AS 12, Income taxes, whereas the other amendments notified by these rules are primarily in the nature of clarifications. The impact of the amendment on the Financial Statements is expected to be insignificant on the basis of the preliminary evaluation.

The Board provides guiding principles for overall risk management as well as policies covering specific areas such as foreign exchange risk, credit risk and investment of surplus liquidity.

#### A. Credit risk

Credit risk refers to the risk of a counter party default on its contractual obligation resulting into a financial loss to the Group. The maximum exposure of the financial assets represents trade receivables, work in progress and receivables from group companies and others.

Customer credit risk is managed by the Group through established policy and procedures and control relating to customer credit risk management. Trade receivables are non-interest bearing and are generally carrying upto 90 days credit terms. The Group has a detailed review mechanism of overdue customer receivables at various levels within organisation to ensure proper attention and focus for realisation. Trade receivables are consisting of a large number of customers. Export receivables are backed by forward contract. In respect of trade receivables, the Group uses a provision matrix to compute the expected credit loss allowances for trade receivables in accordance with the excepted credit loss (ECL) policy of the Group.

# B. Liquidity risk

Liquidity risk is the risk that the Group will encounter difficulty in raising funds to meet its commitments associated with financial instruments. Liquidity risk may result from an inability to sell a fianncial aseets quickly at close to its fair value.

The Group manages liquidity risk by maintaining adequate reserves and banking facilities by continuously monitoring forcast and actual cash flows and by matching the maturity profiles of financial assets and liabilities.

#### C. Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Such changes in the values of financial instruments may result from changes in foreign currency exchange rates, interest rates, credit, liquidity and other market changes.

The Group has several balances in foreign currency and consequently, the Group is exposed to foreign exchange risk. The Group evaluates exchange rate exposure arising from foreign currency transactions and follows established risk management policies.

#### a) Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's long-term debt obligations with floating interest rates. The Group manages its interest rate risk by having a balanced portfolio of fixed and variable rate loans and borrowings.

#### b) Interest rate sensitivity:

## Note 37 **Segment reporting**

For management purposes, the Group is organised into business units based on its products and services and has two reportable segments, as

- a) Alumina Refactories & Monolithics products & bauxite ores: Alumina Refactories & Monolithics products manufactures calcined bauxite, fused aluminium oxide abrasive grains and low cement castables which are mainly consumed in steel plants. Plant grade bauxite ores are captively consumed at the plant and Non plant grade bauxite ores are sold in the market
- b) Power generation: The Group has a thermal power plant, furnace oil based power plant and windmills. Power generated from thermal power plant and furnace oil based power plant is captively consumed at the plant and power generated from windmills is sold to the respective state power distribution companies.

No operating segments have been aggregated to form the above reportable operating segments.

The Executive Management Committee monitors the operating results of its business units separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on profit or loss and is measured consistently with profit or loss in the financial statements. The Group's financing (including finance costs and finance income) and income taxes are managed on a Group basis and are not allocated to operating segments.

Transfer prices between operating segments are on an arm's length basis in a manner similar to transactions with third parties.


